 - 3. Senator McLarty suggested that it might be good to approve full funding because it can encourage other people to apply for funding requests in the future.
 - 4. Senator Ferguson and Senator McLarty concur that students should be prioritized when making decisions, ensuring that students get the most benefits when taking action on the funding request.
 - 5. The ASSC suggested approving \$2,000 for the NCECA-CCACA Funding Request.
 - a. Senator McLarty moved to transfer \$3,000 from the ASSC Reserved Account to the 2021-2022 ASSC Budget (Line 70300: Club Funding Request). Senator Ferguson seconded. Senator McLarty, Senator Ferguson, and Senator Moe voted aye. The motion passed by majority.
 - b. Senator Ferguson moved to approve \$2,000 for the NCECA-CCACA Funding Request. Senator Moe seconded. Senator McLarty, Senator Ferguson, and Senator Moe voted aye. The motion passed by majority.
